



## Development of the Charger Submission Form

The New Jersey Board of Public Utilities (BPU) manages the charger eligibility process for the Charge Up New Jersey Incentive. Charger models will be approved by BPU on an ongoing basis and placed on an Eligible Charger List for incentives. A continuously updated list of eligible chargers and incentive amounts will be maintained on the designated Charge Up New Jersey website. Charger manufacturers must submit a completed Eligibility Application to BPU to have their chargers considered for incentive eligibility. The manufacturer is responsible for providing all the required documentation described on the application. BPU will coordinate with manufacturers to request any additional documentation needed for determining final eligibility. BPU will provide the administrator the current Eligible Charger List and the corresponding incentive amounts.

Only a Level-Two EV charger that is ENERGYSTAR certified and capable of capturing data (also known as a “smart” or networked” charger) intended for residential use is eligible for an incentive. Networked chargers must be on the state’s pre- approved list [state’s pre-approved list](#) . All other chargers are ineligible for this incentive.
